ANNUAL GENERAL MEETING OF SHAREHOLDERS

(the "Meeting") of RP Rendite Plus ("the Company") will be held at the Registered Office at 6A, route de Trèves, 2633 Senningerberg, Luxembourg, on **Friday 18 January 2019** at **11:45 a.m. CET** for the purpose of considering and voting upon the following matters:

Agenda:

1. Acceptance of the report of the Board of Directors and the report of the independent Auditor and to approve the financial statements as well as the use of income (if any) for the accounting year ended September 30, 2018.
2. Discharge of the Board of Directors of the Company in the exercise of their mandate during the accounting year ended September 30, 2018.
3. Re-election of Mr Sven Schäfer, Ms Carina Feider and Mr Heiko Tilmont as Directors of the Board until the next Annual General Meeting.
4. Election of PricewaterhouseCoopers, Société coopérative, Luxembourg, as Auditor until the next Annual General Meeting.
5. Consideration of such other business as may properly come before the Meeting.

Voting:

Resolutions on the Agenda of the Meeting will require no quorum and will be taken at the majority of the votes expressed at the Meeting. The quorum and majority requirements will be determined in accordance with the outstanding shares on 13 January 2019 midnight CET (the "Record Date").

The voting rights of Shareholders shall be determined by the number of shares held at the Record Date.

Voting Arrangements:

Authorized to attend and vote at the meeting are shareholders who are able to provide a confirmation from their depository bank or institution showing the number of shares held by the Shareholder as per the Record Date to Allianz Global Investors GmbH, Luxembourg Branch, Fund Setup, 6A, route de Trèves, L-2633 Senningerberg, Luxembourg, to arrive in Luxembourg by close of business of 16 January 2019.

Any shareholders entitled to attend and vote at the meeting shall be entitled to appoint a proxy to vote on his/her behalf. The proxy form, in order to be valid, must be duly completed and signed under the hand of the appointer or his/her attorney or if the appointer is a corporation, under its common seal or under the hand of a duly authorised officer, and sent to Allianz Global Investors GmbH, Luxembourg Branch, Fund Setup, 6A, route de Trèves, L-2633 Senningerberg, Luxembourg, to arrive in Luxembourg by close of business of 16 January 2019.

A proxy does not have to be a shareholder of the Company. The appointment of a proxy will not preclude a shareholder from attending the meeting.
