Proposed Merger of Allianz China Fund, a sub-fund of Allianz Global Investors Fund VI plc, with Allianz All China Equity, a sub-fund of Allianz Global Investors Fund

Dear Shareholder,

We refer to the circular issued to you on 02 August 2019 in relation to the proposal to merge a sub-fund of the Company, Allianz China Fund (the "**Merging Fund**"), with Allianz All China Equity (the "**Receiving Fund**"), a sub-fund of Allianz Global Investors Fund.

The purpose of this circular is to inform you that **at the extraordinary general meeting ("EGM") of the Merging Fund held on 26 August 2019, a resolution approving the merger of the Merging Fund into the Receiving Fund, on the basis of the terms submitted to the Central Bank of Ireland, was passed by the Shareholders.** The merger will now take effect on 06 November 2019 (the "**Effective Date**").

Fund merger procedure:

On the Effective Date, shares of the Receiving Fund will be credited to investors in the Merging Fund. In return, the Receiving Fund receives the assets of the Merging Fund. There will be no change to the investment policies of the Receiving Fund.


The auditors of the Merging Fund will validate certain aspects of the merger as set out in the Circular. We will provide you with the report issued by the auditors free of charge upon request.

The latest time for the receipt of an application to redeem shares of the Merging Fund prior to the Effective Date shall be 10:00am (Irish time) on 29 October 2019. Such redemptions shall be free of any charges and subject to the usual procedures set out in the Prospectus. Please note that Shareholders who have not redeemed out of the Merging Fund prior to the Effective Date, irrespective of whether or how they voted at the EGM, shall on the Effective Date, become shareholders in the Receiving Fund and their shares in the Merging Fund will cease to have any value or effect.

No further Shareholder meeting or vote is necessary in connection with the above. Shareholders should carefully review this notice and the Circular and are encouraged to consult with their legal and tax advisors with respect to the contents.
