Dear Shareholder,

After careful consideration, the Board of Directors of Allianz Global Investors Fund (SICAV) (the "Company") has decided to liquidate the Sub-Fund **Allianz Global Investors Fund - Allianz Social Conviction Equity** (the "Sub-Fund").

As a result of a yearly review of strategic priorities and business opportunities, the Sub-Fund has not been retained within the portfolio of investment vehicles to be offered to clients.

The Sub-Fund may need to deviate from its contractual investment restrictions for a limited period of no more than five Valuation Days prior to the **date of putting the Sub-Fund into liquidation on 2 December 2025 (the "Effective Date")**. To ensure smooth operational and investment-related liquidation activities, the Sub-Fund's portfolio will be liquidated over a period of multiple days after the Effective Date (the "Liquidation Period"), also resulting in additional NAV being calculated for no longer than five Valuation Days.

The **subscription applications** for shares of the Sub-Fund received at the respective account-keeping entities, the Distributors, Paying Agents or at the Registrar and Transfer Agent **by 11.00 a.m. CET on 25 November 2025** will be executed. The subscription applications for shares received at the respective account keeping entities, the Distributors, Paying Agents or at the Registrar and Transfer Agent after this time will not be considered for execution.

The **redemption applications** for shares of the Sub-Fund received at the respective account-keeping entities, the Distributors, Paying Agents or at the Registrar and Transfer Agent **by 11.00 a.m. CET on the Effective Date** will be executed. Any liquidation proceeds that could not be distributed to (or that were not claimed by) Shareholders after the Effective Date will be deposited with *the Caisse de Consignation* in Luxembourg, where they can be claimed by owners for a period of 30 years.

It may occur that unplanned/ad-hoc holidays are announced in certain markets, which would prevent the calculation of net asset value for the Sub-Fund, leading to the necessity to change the Effective Date to the next valuation date.
