Dear Unitholder,

The management company Allianz Global Investors GmbH (the "Management Company") has decided to dissolve the **Allianz FinanzPlan 2025** (the "Fund") in accordance with Section 19, no. 1, Half Sentence 2 of the Management Regulations of the Fund. Due to the attainment of the indicative target date specified in the sales prospectus and management regulations, 31 December 2025, as well as anticipated extensive redemptions and the correspondingly low assets under management, effective management of the fund is becoming increasingly difficult.

The Fund may need to deviate from its contractual investment restrictions for a limited period of no more than five valuation days prior to the date of putting the Fund into liquidation on 03 March 2026 (the "Effective Date"). To ensure the smooth running of operational and investment-related liquidation activities, the Fund's portfolio will be liquidated over a period of several days after the Effective Date (the "Liquidation Period"), which will also result in an additional net asset value being calculated for a maximum of five valuation days.

Purchase orders for units of the Fund that are received at the respective custodians, distributors, paying agents or at the registrar and transfer agent by 2.00 p.m. CET on 24 February 2026 will be executed. Purchase orders that are received at the respective custodians, distributors, paying agents or at the registrar and transfer agent after this time will not be considered for execution.

Redemption orders for units of the Fund that are received at the respective custodians, distributors, paying agents or at the registrar and transfer agent by 2.00 p.m. CET on 03 March 2026 will be executed. Redemption orders that are received at the respective custodians, distributors, paying agents or at the registrar and transfer agent after this time will not be considered for execution.

The liquidation costs will be borne by the Management Company.
